## 1. Introduction

- 1. **Organizer:** This quiz contest ("**Contest**") is organized by **Shyam Metalics and Energy Limited,** ("**ShyamMetalics" or "us" or "we"**) a company registered under the Companies Act, 1956, and having its registered office at Viswakarma Building,1<sup>st</sup> Floor, 86C, Topsia Road, Kolkata-700046.
- Purpose: This Contest is designed to promote various products and brands of ShyamMetalics amongst the prospective participants ("You" or "Participant(s)") by setting out a mechanism to enable the Participants to participate in the Contests on the terms and conditions (as defined herein below).
- 3. **Special Conditions:** The specific details of the Contest, including, but not limited to the (i) the Start Date and Time; (ii) End Date and Time; (iii) Number of Prizes; (iv) Amount and type of Prizes; (v) Social Media Platform Hashtag Details; (vi) Mode by which Prizes will be sent (i.e., either by courier or collection in ShyamMetalics office); (vii) location specific Eligibility Criteria; will be set out in the Special Conditions published for each specific Contest. The Special Conditions will be governed by these terms and conditions ("**T&Cs**").
